Three statistical authorities – England and Wales, Northern Ireland and Scotland.

England and Wales and Northern Ireland census in 2021 – Scotland in 2022.

Univariate and multivariate tables available. Microdata and flow data from England and Wales. Northern Ireland due 2024 and Scotland 2025.

Ambition to move to population data derived from administrative data – used significantly in producing the census estimates. Robust individual level testing on quality of data.

## Output area geography

Output area minimum 40 households and 100 residents, average target 125 households, maximum 250 households and 625 people

- introduced in 2001
- aim for more homogeneous population through matching characteristics of population
- but try to minimise changes

Built into larger super output areas

- lower level super-output areas (LSOAs) minimum 400 households and 1,000 people, maximum 1,200 households and 3,000 people – used in published statistics e.g. IMD, recorded crime
- Mid-level super output areas (MSOAs) minimum 2,000 households and 5,000 people, maximum 6,000 households and 15,000 people – used in published statistics e.g. educational attainment, Covid cases

All boundaries constrained within local authorities

## Univariate data

#### **Topic summaries**

#### Multivariate data

Defined sets of tables including two or more variables at different geographical scales

Flexible table builder (incorporating statistical disclosure control)

The variable categories will vary between univariate and multivariate tables based on statistical disclosure control. This is likely to mean the need to balance geographical scale and the level of detail available.

#### Other types of data

- Flow data origin destination data covering migration flow, workplace flow, second address flow, student flow
- Microdata multivariate sample from the census
- Alternative population bases workplace, workday, out-ofterm, second address
- Small populations Ethnic group, Country of birth, Religion, National identity

#### Accessing the data

UK Data Service (UKDS), NOMIS and ONS provide topic summaries for individual variables.

UKDS and NOMIS present a defined set of multivariate tables. They use less detailed categories in many cases.

ONS interface allows you to select variables to create a custom dataset and select the number of categories. The interface tells you the effect of statistical disclosure control.

NOMIS output is tabular, UKDS and ONS has a line for each category.

## Boundary data products

Focussing on England and Wales releases but broadly applicable to Northern Ireland and Scotland



#### Accessing data

Provides data in SHAPEFILE, KML, Mapinfo TAB and CSV format. The data is open access so does not require registration.

- All boundaries for each country or UK
  - Easy Download
- Selected boundaries to subset dataset
  - Boundary Data Selector





## Microdata products

Focussing on England and Wales releases but broadly applicable to Northern Ireland and Scotland



#### Accessing data

Census microdata provides the potential for more complex multivariate analysis

- Open data is available from ONS and UKDS
- Safeguarded data is only available from UKDS and you need to be registered to access it
- Secure data is only available to accredited researchers and is subject to approval of your proposed research. It can be accessed through ONS or UKDS.

#### Datasets

Individual

- 1% open access at regional level (18 variables)
- 1% safeguarded access IPUMS (internationally deposited)
- 5% safeguarded access combined local authority (85 variables)
- 5% safeguarded access region (86 variables)
- 10% secure access local authority

Household

- 1% safeguarded access household data at regional level (55 variables)
- 10% secure access local authority



## Flow data products

Focussing on England and Wales releases but broadly applicable to Northern Ireland and Scotland





Flow data provides datasets holding origin and destination data for analysis of commuting, internal migration, second homes and student term-time and home address together with individual level variables.

The safeguarded datasets for 1981 – 2011 are available from UKDS and a bulk download is available for 2021 <u>here</u>.

A new interface is being developed and this will provide access to all data. It is expected to be released in early 2025 and we will be providing training and support materials.
